### Why are these cases so challenging?


- Main tool of child welfare intervention is removal
- Pervasive victim blaming derived from moral constructions
- Struggles to meaningfully engage with the parent using violence and coercive control
- Fear, burden, and liability



### When Child Welfare Gets Involved

- Regulation of families of color, disproportionality, disparity, and inequity
- Can escalate the domestic violence
- Disconnect of adult and child survivors from each other in the face of what children need to heal
- Compounding trauma
- Increased risk of abuse and neglect in foster care and poor outcomes for foster youth
- Severance from source of healing
- Failure to foster avenues of accountability
- Missed opportunities to interrupt cycle of abuse
- Freezing effect on help-seeking behavior
